**Thursday, November 17, 2011** – Set-up quilt show, 8:00 am to approx. 6:00 pm. **Preview Party** from 7:00 to 9:00 pm.

**Friday, November 18, 2011** – Quilt Show open to the public from 10:00 am to 6:00 pm. \$7.00 per person admission charged to attendees aged 13 and above.

**Saturday, November 19, 2011** – Quilt Show open to the public from 10:00 am to 6:00 pm. \$7.00 per person admission charged to attendees aged 13 and above.

**Sunday, November 20, 2011** – Quilt Show open to the public from 10:00 am to 4:00 pm. \$7.00 per person admission charged to attendees aged 13 and above.

**Sunday, November 20, 2011** – Please arrive at the Scottish Rite Masonic Center by 4:00 pm to help take down the show. **NO ENTRIES WILL BE RELEASED UNTIL THE QUILT SHOW IS COMPLETELY TAKEN DOWN AND PACKED IN THE MOVING TRUCK!**

Estimated time to begin releasing entries is 6:00 pm.

**Quilt Show Entry Rules and Procedures**

1. Any RCQG member can enter a cloth quilt by submitting the entry form and a color photo of the entry. Photos should be clearly labeled with the exhibitor's name and quilt size in inches (width by length: width measurement is the side to side measurement of the quilt, length measurement is the top to bottom measurement of the quilt).
2. A non-RCQG member may enter a cloth quilt by submitting an entry form and color photo. Photos should be clearly labeled with the exhibitor's name and quilt size (width by length: width measurement is the side to side measurement of the quilt, length measurement is the top to bottom measurement of the quilt). Entries from non-members will only be accepted on a space available basis. Preference will be given to RCQG members.
3. Only ONE (1) entry per entry form.
4. Exhibitors are limited to six (6) entries total. Four (4) entries may be judged - only one (1) judged entry per category.
5. All entry forms, fees and photos are due by September 20, 2011. Exhibitors will receive confirmation by mail upon receipt of their application.
6. ALL QUILTS MUST HAVE A 4-INCH SLEEVE SEWN ON THE TOP OF THE BACK.
7. All entries must be complete, undamaged and clean; free of smoke, odor, and hair/fur; and constructed of fabric.
8. All entries must have an official Quilt Show 2011 Entry Label (see Page 6) sewn on the lower right-hand corner of the back of the entry.
9. Quilts must be constructed and quilted by person(s) named on the entry form.
10. All quilts must be quilted.
11. Labels or other information identifying the quilt maker/quilter on items to be judged must be covered with fabric or paper.
12. Entries displayed in previous RCQG quilt shows are ineligible.
13. All entries submitted for judging must include a \$10.00 fee per item. Junior Entrants are not required to pay a \$10.00 entry fee for complimentary judging.
14. Judged entries must be delivered by 8:45 am, Wednesday, November 16, 2011.
15. Exhibited only items must be delivered by 10:30 am, Wednesday, November 16, 2011.
16. Entry must be available for display from November 18 through 20, 2011.
17. The RCQG Judging Committee reserves the right to re-categorize any item or disqualify any item from the judging portion of the quilt show.
18. Junior quilts receive participation ribbons and complimentary judging comments. See Page 5 for detailed information.
19. QUILT SHOW CHALLENGE QUILTS MUST BE COMPLETED BY, DISPLAYED AT AND ARE VOTED ON BY GUILD MEMBERS AT THE OCTOBER 18, 2011 GUILD MEETING. Challenge participants who plan to exhibit their quilts at the Quilt Show must complete and submit an entry form by September 20, 2011. The Quilt Show Challenge instructions are on Page 4. Challenge participants may also submit their quilts for judging in a category that meets the definition for that category by checking the appropriate box under **Judging Categories** on Page 1 (see Page 4 for **Definitions of Categories and Sizes**).
20. Photography is allowed during the quilt show.

**Quilt Show Challenge Instructions**

A "Symphony of Color" is the challenge for 2011. Challenge fabric packets are available from Janet Van Wert (916-489-3097 or [fwvw1@juno.com](mailto:fwvw1@juno.com)). Packets contain 1/4 yard of the focus fabric, 1/8 yard of the accent fabric. Both fabrics must be seen on the front of the quilted item. Additional fabric is available; contact Janet for information as to where to purchase the fabric. Anything quilted is accepted. No size requirements or restrictions. Items must be finished by and exhibited at the October 18, 2011 Guild meeting to be judged by the Guild members. Three categories will be judged by the Guild members: 1. Best Use of Fabric; 2. Best Interpretation of the Quilt Show theme "Symphony of Color"; 3. Viewer's Choice. Challenge entrants are encouraged to exhibit their creations in the Quilt Show in November. Challenge participants may also submit their quilts for judging in a category that meets the definition for that category by checking the appropriate box under **Judging Categories** on Page 1 (see Page 4 for **Definitions of Categories and Sizes**). **Judging Guidelines for the RCQG Quilt Show**

1. Judging will be by the elimination method.
2. First Place, Second Place, Third Place and Honorable Mention Awards MAY be awarded in each category at the sole discretion of the judges. Winners will receive ribbons.
3. Judges determine award of the following Optional Special Awards: Best of Show, Best Use of Color, Best Hand Quilting and Best Machine Quilting. Winners will receive ribbons.
4. Each Judge may present one Judge's Choice Award from any category of the items entered for judging. Winners will receive ribbons.

**Optional Special Awards are as follows:**

Best of Show \$150	Judges' Choice \$50 (One Per Judge)
Best Use of Color \$100	Challenge Award – Chosen by Members at the October 18, 2011 Guild Meeting.
Best Hand Quilting \$100	Ribbons will be awarded to the winners.
Best Machine Quilting \$100	Harriet Merriam Award - Viewers' Choice will be awarded on November 20, 2011 at 3:00 pm. The winner will receive a ribbon.

**Definitions of Categories and Sizes:**

1. Pieced: Piecing predominates over appliqué or other technique either in amount or effect.
2. Appliqué: Appliqué predominates over piecing or other techniques either in amount or effect.
3. Pieced & Appliqué: A combination of piecing and appliqué where neither predominates more than approximately 60%.
4. Art: An original design meant to be used as a piece of art
5. Scrap: Quilt top is comprised of 50 or more different fabrics..
6. Folk Art: Folk art refers to the art of the people as distinguished from the elite or professional product of mainstream art. Folk art is also known as "primitive", "rough", "and un-schooled". Items in this category should capture cultural, primitive or country characteristics.
7. Miniature: Any quilt with a maximum circumference of 100" and is to scale.
8. All Other Techniques: Various techniques including stenciling, wholecloth, yo-yo, cathedral windows, ragged, crazy quilts, machine embroidery, etc., or a combination of techniques.
9. Adult First Quilt: Quilt must be a first quilt completed by an adult.
10. Group Quilt: Any quilt top made by three or more persons.
11. Two-Person Quilt-Pieced: Any quilt made by two people (e.g. pieced by one person and quilted by another); piecing predominates over appliqué or other technique either in amount or effect.
12. Two-Person Quilt- Appliqué: Any quilt made by two people (e.g. pieced by one person and quilted by another); appliqué predominates over piecing or other techniques either in amount or effect.
13. Two-Person Quilt-Pieced & Appliqué: Any quilt made by two people (e.g. pieced by one person and quilted by another); a combination of piecing and appliqué where neither predominates more than approximately 60%.
14. Wearable Art: Single Item (e.g. vest, jacket); Ensemble/Dress; Accessory (e.g. purse, tote bag)

**Small:** Circumference\* is up to 216" or less.

**Medium:** Circumference\* is between 216" and up to 300".

**Large:** Circumference\* is 300" or more.

\*Circumference is the total outer boundary, also known as the perimeter, measurement of the quilt.

#### Quilt Show Entry Rules and Procedures for Juniors

1. Only ONE (1) entry per entry form.
2. A color photo of the entry must be included with the entry form. Photos should be clearly labeled with the exhibitor's name and quilt size in inches (width by length: width measurement is the side to side measurement of the quilt, length measurement is the top to bottom measurement of the quilt).
3. Please complete the Entry Information on Page 1.
4. The entry form must be signed on the bottom of Page 1 "Insurance Waiver and Assumption of Loss" by the Junior entrant's parent or legal guardian.
5. Exhibitors are limited to three (3) entries total and only one (1) entry per category.
6. ALL ENTRIES MUST HAVE A 4-INCH SLEEVE SEWN ON THE TOP OF THE BACK OF THE QUILT.
7. All entries must be complete, undamaged and clean; free of smoke, odor and hair/fur; and constructed of fabric.
8. All entries must have an official Quilt Show 2011 Entry Label (see Page 6) sewn on the lower right-hand corner of the back of the entry.
9. Entries displayed in previous RCQG quilt shows are ineligible.
10. Entries must be available for display from November 18 through November 20, 2011.
11. Junior entrants receive participation ribbons, plus complimentary judging comments and placement award ribbons.
12. Junior entries are divided into two age group categories: "12 and under" and "13 to 17". Entrants must select an age group category.
13. Entry Description: On Page 2 of 6, please write a BRIEF history or comments of interest about your entry.
